SURREY COUNTY COUNCIL PROPOSE TO MAKE The Surrey County Council (Ash Green Lane West (Right of Way 518, D80) and Spoil Lane (Right of Way 519, D74) in the Parishes of Ash, Normandy and Tongham) (Prohibition of Through Traffic) Amendment Order 2017- under Sections 1 and 2 and Parts III and IV of Schedule 9(2) of the Road Traffic Regulation Act 1984, the effect of which would be to shorten the existing prohibition on all motor vehicles and horse drawn carriages from entering or proceeding along BOAT 518 (Ash Green Lane West) so that it would apply to that length which extends from a point 317 metres east of Manor Road (Grid Ref. 4890 1496) in an easterly direction for 430 metres to its junction with BOAT 520 Ash (Grid Ref. 4895 1497) as shown on Drg. 3/1/54/H22. The prohibition would not apply to vehicles which need to use the BOAT for the purpose of exercising any statutory duty therein or the exercise of private vehicular rights.
